Declaration of the food safety:

The meat marking pencil is suitable for processing food.

Declaration on Regulation (EC) No. 1333/2008 on food additives:

The meat marking pencil meets the requirements of Regulation (EC) No. 1333/2008 for processing aids. The food colorings E133 and E129 used are listed as additives in this regulation. The ingredients processed in the meat marking pen are considered processing aids because the pen

- a) is not consumed as a food by itself;
- b) is intentionally used in the processing of raw materials, foods or their ingredients, to fulfil a certain technological purpose during treatment or processing; and
- c) may result in the unintentional but technically unavoidable presence in the final product of residues of the substance or its derivatives provided they do not present any health risk and do not have any technological effect on the final product;

Declaration on Regulation (EC) No. 1935/2004

on materials and articles intended to come into contact with food:

The meat marking pencil meets the general requirements of Regulation (EC) No. 1935/2004. It is manufactured in compliance with good manufacturing practice so that, under normal or foreseeable conditions of use, it does not transfer its constituents to food in quantities which could:

- a) endanger human health; or
- b) bring about an unacceptable change in the composition of the food; or
- c) bring about a deterioration in the organoleptic characteristics thereof.

The purity of the processed raw materials is checked regularly.

Composition:

The meat drawing or meat marking pencils No. 698 are wood-cased colored pencils with solid leads. The present solid leads are made up of binders, dyes, fillers and a fat/wax mixture as well as additives. The food colorants used are Acid Blue 9 C. I. No. 42090 = E 133 and Food Red 17 C. I. No. 16035 = E 129.

Statement of absence of allergens:

Allergens are not intentionally added to the product during production. The composition does not include ingredients known to be allergens.

Traceability flow:

Traceability flow is granted by two-digit production code stamped on the pencil, which gives information on the production date.

Material:

The Faber-Castell Meat Marking Pencils No. 698 (Ref.-No. 216983 brown and Ref.-No. 216984 blue) are woodcased pencils. The raw materials of the leads are binders, food-dyestuffs, filler, a fat-/wax-mixture and additives.

The food-dyestuffs are Acid Blue 9, C. I. No.: 42090 = E 133 and Food Red 17, C. I. No.: 16035 = E 129.

The leads conform to the regulations 94/36/EG, VO 1935/2004 and VO 1333/2008.
